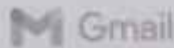

2. Compliance

The compliance study was carried out through investigative ways. This was done to understand the **extent of suggestions and their implementations based on previous report of Academic years 2019-2020 and 2020-2021.**

The details of the suggestions are based on the Original Report dated 29 September 2021 is further upgraded. The Report shared by the College is documented below:

2.1 Stakeholder participation

Unnat Bharat Abhiyan is inspired by the vision of transformational change in rural development processes by leveraging knowledge institutions to help build the architecture of an Inclusive India.

Under this Abhiyan many Colleges of Pune got participated among them Asian College of Science and Commerce was also a participant. As the meaning and motive of UBA goes our College also visited the villages and has completed a survey in which our student got to know about the problems that people are suffering in those areas. The villages that our students visited are:-

- Awasarenagar
- Arvi
- Kalyan
- Panshet
- Kirkatwadi

According to the survey we found many problems that were faced by the villagers and one of the major problem was 24 hours water supply. Then we faced the problem of supply of electricity that was the electricity supply was according to the load shading in which the light was not there almost for 7 hours per day.

One problem that we faced that was kaccha road which was not able to reach the people on time to their destination. Then our student went to the Gram Panchayat and tried to solve the problem.

We also attended a Gramsabha which took place in the villages. Our students also arranged a cake making and paper bag making workshop for needed house women who live in that village. We also took a teaching program in which students of our college taught children about personality development and recent technologies.

2.2 Waste management

- Incinerator machines have been put up at the premises
- Twin litter dustbins have been installed
- Sealed septic tank has been undertaken, however we feel the hygiene of this space can be improved.

3. Inferences

3.1 Section-wise recommendations

The following suggestions are to be considered as a **first priority** for implementation. These **should be executed within the next 1.5 to 2.5 years from the date of the Report submission.** The Institute can execute a plan after discussion with Project Head.

3.1.1 Stakeholder participation

- **Environmental awareness** - There can be various artworks on the compound wall giving the message of saving the environment through the joint efforts of the students and staff thereby making the student socially and environmentally responsible citizens.

3.1.2 Waste management

- **Signages** - Messages about avoiding wastage should be placed at appropriate locations.
- **Material of the dustbin** - The current plastic dustbins should be replaced with eco-friendly material.

3.1.3 Hygiene management

Compound wall – The compound wall should have awareness messages about 'No Smoking' and 'No Tobacco'

2. Compliance

The compliance study was carried out through investigative ways. This was done to understand the **extent of suggestions and their implementations based on previous report of Academic years 2019-2020 and 2020-2021.**

The details of the suggestions are based on the Original Report dated 29 September 2021 is further documented below. It is based on the data collection process.

The information for the current nos. of electrical appliances is documented below

- **Lights, Air conditioners, Equipment** - There have been a campus up gradation and better strategies for the newly constructed premises.
- **Fans** – The College has replaced regular ceiling fans with energy efficient fans.
- **Net metering devices** – The building has been replenished to a great extent and the solar system has been connected to the net metering device.
- **Solar panels have been installed in the premises.**

3. Inferences

3.1 Section-wise recommendations

The following suggestions are to be considered as a **first priority** for implementation. These **should be executed within the next 1.5 to 2.5 years from the date of the Report submission**. The Institute can execute a plan after discussion with Project Head.

3.1.1 Desktop computers to laptops

Among all equipment, it suggested replacing the desktop computers with laptops as this would be energy efficient. A normal desktop computer consumes an average of 250W and it is to be connected all time when it has to be used. On the contrary, a laptop consumes 40W and has a battery backup that lasts up to 4 hours. There is **an average 84% reduction** in energy consumption if replaced with an energy-efficient appliance which is a laptop in all the areas.

3.1.2 Ceiling Fans

The current Fans are in proper working conditions and maintained well. The ceiling fans are in more quantity and consume at least 60W when in use. These should be replaced with energy efficient fans consuming 35W when in use.

Our detailed study states that is all the **ceiling fans on all floors** if replaced with star rated appliance results in a reduction of average of **42% reduction** It will be suggested to replace when fans get damaged or are not in working condition.

3.2 Consolidated study recommendations related to 'entire Institute'

The following details are consolidated study recommendations related to 'entire Institute' and should be considered as **second priority** for implementation, once the section wise recommendations are implemented. The following recommendations should be ***implemented within 2.5 to 3.5 years from the date of the Report submission.***

3.2.1 Solar tree

Since there is availability of space and technical school; the option of providing an aesthetic beauty to the premises and benefit w.r.t to energy reduction can be provided with installation of solar tree in multiple places in the site.

- **Fire safety** – The refilling of the extinguishers is done and additional extinguishers have been added recently.
- **User friendly** – There are seating arrangements provided for the students and staff members.
- **Eco-friendly products** – There are Low VOC paints and adhesives used in the premises which are environment and user friendly.
- **Shaded roofs** – The solar panels have been installed on the rooftops which provide shade to the roof and keeps temperature under control.

3. Inferences

3.1 Section-wise recommendations

The following suggestions are to be considered as a **first priority** for implementation. These **should be executed within the next 1.5 to 2.5 years from the date of the Report submission**. The Institute can execute a plan after discussion with Project Head.

3.1.1 Universally accessible premises

- **Provisions for visually impaired - Signages** – In addition to the signages being in regular language there should be additional signages in braille language for the specially-abled students.
- **Provisions for visually impaired - Audio Visual Section** – There should be dedicated section for ther visually impaired students to listen to the audio books; Abrar the audio book reader should be available.
- **Provisions for hearing and speech impaired – Sensor based fire system** – There should be smoke detectors, sensor based facilities and signages, floor layouts for emergency situations such as fire. Additionally, one maintenance staff should be allocated for assistance at every corner of the Institute.

3.1.2 Life safety

- **Fire and life safety practices** – Provisions such as signages, fire alarm, smoke detectors, fire hydrant cabinets, sand buckets, hose reel, fire cabinet, fire water tank and fire pump near the entrance block whichever is applicable should be practiced.
- **Awareness** - Fire layouts in immediate spaces outside the lift, on the staircase landing, signages mentioning 'Do not use lift in case of fire' additionally fire exit signages, boards should be put up at all possible locations.
- **Sensitization programs** - Regular seminars/ webinars by experts such as Architects, Govt. Fire department on subjects related to fire and life safety should be organized and the outputs should be adopted and documented.

3.1.3 Pollution Control

- **Bicycles as a gift** - As an appreciation gesture maybe the student's toppers/ staff best performers can be awarded a bicycle occasionally.
- **Avoid using plastic in premise** - There should be a provision for a ban on the use of plastic bags or products on the Premise.
- **Paperless technologies for offices** - The Institute can go technology-friendly and go paperless in the functioning of the Premise to a certain extent maybe not fully.




